Policy for lifelong learning

- In our country we have developed and implemented the "National Strategy for lifelong learning for the period 2014-2020, which sets the following goals:
- Expanding the system of career guidance and ensuring the conditions for the formation and development of skills for career planning



- Expanding the use of the European system of identification, assessment and certification of knowledge, skills and competences.
- Implementing a system for forecasting the needs of the labor market.
- Creating tools and platforms for e-learning
- Promotion of lifelong learning and more.

 Under the plan, the strategy is necessary to raise participation of the population aged 25 to 64 years in education and training from 1.5 in 2012 to more than 5% in 2020.

- Improving the system of financing.
- Construction of suitable educational environment.
- Introducing a system of validation of knowledge, skills and competences.

Legal regulation in healthcare (for graduates working in Health System)

Duration of training - 2 years

Organization

- Every year plan places specialization of university or hospital
- The specialization is carried out in developed and approved Curriculum
- The program includes practical and theoretical training
- The training ends with a state exam
